Annual Return

You must submit the return within seven months of the end of your society's financial year end. An annual return is required however short the period and regardless of whether or not the society has effectively begun operations.

Fees

Your society will be required to pay a fee to us annually, beginning with the first FSA financial year following its registration. Our financial year runs from 1 April to 31 March and we will send an invoice to your society about half way through this period. The amount your society will pay is based on the total assets disclosed in its annual return in the preceding year of accounts.
