- Standing Order - Payable to Leek Town FC - Monthly Draw" Barclays Bank Plc, Sort Code 20-48-70, Account Number 30576255. Complete attached standing order mandate and submit to your bank as soon as your Draw Number has been allocated to you. Please ensure that you include the number and also indicate the frequency of the payment and the date on which each monthly, quarterly or annual payment is to be made.

- Cheque - made payable to "Leek Town FC - Monthly Draw". Which will need to be delivered or posted to Leek Town FC, Monthly Draw, Harrison Park, Macclesfield Road, Leek, Staffs, ST13 8LD by 18th of each month to allow for it to clear before the draw is made.

- Cash - This may be paid to nominated agents for the monthly draw.



LEEK TOWN FOOTBALL CLUB MONTHLY DRAW

1. Membership is restricted to 1,000 on a first come first served basis. On payment of monthly subscription each applicant will be allocated a number from 1 to 1,000.
2. Should the membership become oversubscribed, the Organiser may increase the membership in blocks of 100 numbers with 50% of the additional income being made available for prizes.
3. A record of members' names, addresses and telephone numbers and the number allocated to each member will be maintained by the Organiser, Paul Bateman.
4. The cost of membership will be £5 per month payable in advance to be paid by the 23rd of each month. It is the responsibility of each member to ensure that payment is made on time.
5. The draw will take place on 28th of each month with the first draw being made on 28th January 2011.
6. The result of each draw will be advertised in the Leek Post.
7. Once the membership is fully subscribed, the monthly prizes will be; 1st - £1,000, 2nd - £500, 3rd - 2 x £250, 4th 5 x £100.
8. **Until the membership is fully subscribed, the prize money paid out will be equal to 50% of the total amount collected each month, with prize fund being allocated between 1st, 2nd, 3rd and 4th prizes in the same proportions as stated in paragraph 6 above.**
9. Prizes will only be paid to those members who have paid their contributions in advance of each draw taking place. Should any number be drawn where the member has not paid as described above, that number will be declared void for that month and the prize will be redrawn.
10. If any member fails to pay for more than 2 consecutive months, then that membership will be cancelled and the number will become available to be allocated to any other applicant.
11. The Organiser will open a bank account with Barclays Bank plc, Leek Branch, where all monies will be deposited. Prize moneys will be paid in cash. All withdrawals from the bank account will require two signatories (one of which will be the organiser).
12. The cost of advertising the draw and all related costs for administration of the draw shall be drawn from the fund but shall not exceed 1% of the total income.
13. All profits from the draw will be used for the benefit of Leek Town Football Club at the discretion of the Board of Directors of Leek Town Football Club.
14. Monies may be paid by monthly standing order, by cheque made payable to "Leek Town Football Club - Monthly Draw" or by cash.
15. The draw is promoted by M. A Wain, Leek Town FC, Harrison Park, Macclesfield Road, Leek, under licence number SL0018.
