Tax claimed by HRSSC

HRSSC will reclaim 28p of tax on every £1 you gave up to 5th April 2008

HRSSC will reclaim 25p of tax on every £1 you give on or after 6th April 2008

The government will pay to HRSSC an additional 3p on every £1 you give between 6th April 2008 and 5th April 2011. This transitional relief does not affect your personal tax position.
